It is necessary for developers, owners, and different actors in the market to which the fees apply, to ensure that they have the latest version at the time of requesting the service from the Voluntary Programme on Circular Economy or making the payment.

This document will be updated periodically with the approval of the Board of Directors, either to modify a rate or to include a new one.

Clarifications

To understand the fee schedule of the programme, the following clarifications are required:

- The fees are generated at the time the service is requested from the programme.
- All the fees listed in this document are expressed in U.S. dollars (USD).
- In case of late payment of fees, the programme will block the account in the registration platform until the due payment support is presented.
