

Terms and Conditions

Effective as of 30 June 2026

These Terms and Conditions ("Terms") govern your use of the Cercarbono website, www.cercarbono.com, and any associated subdomains and online services (collectively, the "Website"), provided by Cercarbono ("Cercarbono", "we", "us", or "our").
